## 4. FIRST AID MEASURES

# LANGRIDGE

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

Wear gloves, apron, safety glasses, dust mask. Available information suggests that gloves made from should be suitable for intermittent contact. Wash contaminated clothing and other protective equipment before storing or re-using.
